 - C) Completion of One year Apprenticeship training in any licensed Cinema Theatre in Telangana as on 30-06-2022.
 - D) Completion of 18 years of age as on 01-07-2022.
- 5 Examination fees to be paid : Rs.500/- (Rupees Five Hundred only) along with filled in Application form in complete shape in any one of the following mode of payment.

8. Documents to be attached to obtain application form.

- (a) Requisition on a plain paper for supply of examination application form.
- (b) A Crossed Indian Postal Order for Rs.100/- (Rupees one hundred only) payable to Asst. Accounts Officer(Accounts), Office of the Chief Electrical Inspector to Government of Telangana, Hyderabad towards the cost of application form. The postal order for the purpose should have been drawn after the date of publication of this Notification.
- (c) Self addressed stamped envelop for Rs.40/- of size not less than 25 cms x 10 cms.
- (d) Application can be obtained from the Electrical Inspector/ Hyderabad, 2nd Floor, 132 KV GIS Substation premises, Moosarambagh, Hyderabad.

9. Rs. 40/- stamped self addressed envelop should be attached along with the filled in application form.

NOTE:

1. SC and ST candidates who have appeared in all subjects and passed/failed in VII after studying up to VII in a Government/Government recognised school/Institution shall enclose Xerox copies of VII passed/failed Memo and transfer certificate duly attested by Gazetted Officer at the time of submission of filled in application form only.
2. The completed application form shall be submitted to the Chief Electrical Inspector to Government of Telangana, Hyderabad .
3. The filled in application form received after the due date will not be considered under any circumstances.
4. The employee working in Government/Government undertaking organisations shall process their application through their employer.
5. The original certificates of Educational qualification need not be enclosed to the application. It is enough if certified xerox copies are enclosed.
6. Court fee stamp for Rs. 5/- shall be affixed on the application format at the time of submission.
